ALL EXHIBITORS SHOULD NOTE THE FOLLOWING

- Any exhibitor booking a craft stall will receive 1 vehicle pass and 2 exhibitor passes which will be sent via email. This allows 1 vehicle onto the showground between 7am-9am to unload adjacent to the marquee. Vehicles must be removed to the parking area before 9am. Traders may come on the field 3pm to 5pm to set up on the Friday before the show.
- Outside plots are 20ft x 20ft and will be allocated on a first come first served basis. Adjacent plots will be allocated where requested and available. If you have a location preference, please state it in the initial application and we will try to accommodate your wishes.
- Traders MUST submit completed, signed, and fully paid applications forms before being allowed onto the field.
- All traders must provide a copy of their public liability insurance and appropriate risk assessment.
- Any food related stands will need to provide a copy of their food hygiene certificate
- Traders using cooking equipment will need to provide a written statement of the type of equipment being used and all necessary fire-fighting equipment e.g. fire blankets etc, should also be provided by trader.
- Traders must not use any PA equipment of any description to promote their products.
- Traders must ensure that they have booked enough space for their trade stand and under no circumstances encroach into other trader's space, the avenues or non-trading space.
- When deciding on a marquee etc for your plot, please ensure the marquee etc will fit within your plot including any guy ropes or pegs necessary for stability.
- All stands should be operational (staffed etc) by 9.00am on show day. Exhibitor MUST NOT dismantle their stand before 4.00pm on show without prior permission from show secretary.
- Bowes Agricultural Society does not accept any responsibility for any non-compliance with appropriate legislation. Outside trade stand plots do not have an electricity supply but generators can be operated subject to conditions of noise, safe refuelling and operation.
